SUBJECT: GAF RUBEROID SPECIFICATION -I-1-2-20-MGPFR REQUEST FOR PROPOSAL

GAF is requesting a proposal for the following scope of work on the above Guaranteed roof assemblies to address the slippage of the SBS RUBEROID membrane. The assemblies consist of an insulated deck, base sheet, RUBEROID 20 and RUBEROID Mop Plus FR, set in hot asphalt.

Ashley Stake Building:

- Approximately 800 LF of RUBEROID 20 exposed from slipping membrane.
- Trim membrane overhanging at the edge, approximately 200 LF
- Cut out the buckled areas and fish mouths
- Prime the existing RUBEROID membrane to be torched
- Torch RUBEROID modified APP Granulated cap sheet (white) no less than 12" wide over exposed ply
- Some of the areas will require a full width less the salvage edge to cover
- Be sure there is at least 6" of membrane past the patch areas in all directions

Davis First and Fourth Wards Building:

- Approximately 500 LF of exposed RUBEROID 20 due to slipping membrane
- Trim off membrane at drip edge that is hanging over, approximately 100 LF
- Prime the existing RUBEROID membrane to be torched
- Torch RUBEROID modified APP granulated cap sheet (white) at least 12" wide over exposed ply
- Some of the wider areas will require a strip 16" wide, totaling approximately 500 LF
- Be sure there is at least 6" of membrane past the patch areas in all directions

Proposals to include all materials, labor, insurance, and permits to successfully complete these projects. This will be a lump sum proposal for both projects.
